

***MOOD 2010***  
***10th Doctoral Workshop in Economic Theory  
and Econometrics***  
*EIEF (Rome), June 30-July 2, 2010*

This annual workshop, which started in 2001 as the Villa Mondragone Workshop in Economic Theory and Econometrics, is designed to stimulate the interaction between senior economists and doctoral students working on both theoretical and empirical economic issues, and well ahead in their dissertation. The workshop is the result of the cooperation between five Italian research institutions—Bank of Italy, Bocconi University, Collegio Carlo Alberto, EIEF, and LUISS—that are present on the international academic job market for economists. Additional financial support is provided by the *Journal of Applied Econometrics* and by *LABOUR: Review of Labour Economics and Industrial Relations*.

### **Program**

The workshop will allow a selected group of doctoral students to receive intense feedback on their work from senior economists. Doctoral students will present their work to the other workshop participants (approximately one hour for each work session). The workshop is residential, and both doctoral students and senior researchers are expected to participate to all sessions. The working language is English.

The workshop is open to Doctoral students who are close to finish their PhD. Prospective participants are invited to submit **by April 15** a draft of the paper they intend to present, along with their CV. High quality papers in all fields of economics will be considered. The organizers will then select, **by May 15**, eighteen papers for presentation. The best two papers presented at the workshop will be nominated for the 2010 *Journal of Applied Econometrics Dissertation Prize*.

The Workshop will take place on June 30-July 2, 2010. Arrival is expected on June 29, departure by July 3.
